Payments made after February 1st and all delinquent taxes MUST be mailed to Sawyer County Treasurer, not to the Town of Bass Lake.

DOG LICENSE

If you own a dog that is 5 months or older and reside in Sawyer County more than 30 days, your dog is required by law to have an annual Sawyer County Dog License. Licenses must be purchased no later than March 31st to avoid late fees. Owner must provide the following:

- * Current Rabies Certificate
- * Self addressed stamped envelope (if mailing)
- * Seperate check payable to Town of Bass Lake

Failure to obtain a license prior to April 1st will result in late fees of \$20.00-\$30.00 per dog. **NO** postmarks - late fee will apply.

TOWN OF BASS LAKE HAS A 4% ROOM TAX FOR ANY PROPERTY THAT RENTS OR LEASES FOR OVERNIGHT LODGING.

Ordinance 2021-04-201

If you use a VRBO, Expedia, AirBnB, Homeaway or any other management company, you are required to set up the 4% room tax with them. Make sure the payments are mailed to Town of Bass Lake Treasurer, quarterly, with the property site noted with the payment. As the property owner **YOU** are responsible for sending the accounting each quarter. Quarterly reports are due even if \$0 was collected for the quarter. 

Recommended Mailbox Installations

To avoid damage to your mailbox and also allow the snowplows to remove the snow from under your mailbox, the following dimensions are recommended.



Placing mailboxes a short distance away from driveways and intersections helps to avoid vision-restricting snowbanks and also damage to your mailbox. The box and base should be strong enough to withstand flying snow and slush from traffic and snowplows.
